

#### Facts:

- This is a review application (no. 417 of 2023) filed by the petitioner (New India Assurance Co. Ltd)
- •It seeks to review the final order and judgement dated 13.04.2023 passed by the National Consumer Disputes Redressal Commission in Revision Petition no. 3306 of 2012
- The revision petition was related to a dispute between New India Assurance Co. Ltd (appellant) and M/s Span Packaging & Anr. (respondents)
