### ***Facts***

- *This is a Miscellaneous Application (MA) no. 628 of 2023 filed in the National Consumer Disputes Redressal Commission (NCDRC) in FA/533/2017.*
- *The appellants are Union of India through General Manager, Southern Railway, Chennai, Tamil Nadu.*
- *The respondents are Unni A & Ors, Sudeesh R, Surthi R, K.P.Appa, and Ammukamakshi. All respondents are from Palakkad, Kerala.*

### ***Court's Opinions***

- *The court allowed MA 628 of 2023 and IA 15185 of 2023 filed by the appellants.*
- *The appeal has been restored to its original number.*
- *The restoration is subject to the appellants paying*

*costs of Rs. 20,000 to be deposited in the Consumer Legal Aid Account within 4 weeks.*

- *The matter has been listed on 04.03.2024 for next hearing.*
- *Notice has been issued to the respondents.*

- *No specific sections have been mentioned. This seems to be an application filed under general procedure.*

### **Referred Laws**
